May kindly see the online property statements received from Smt. Anita Raj, Principal Judge, Family Court, Etah regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), total Gross salary is Rs.52,26,873/- and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, FDR, Car loan and the balance of her savings bank account(s) is also enhanced by Rs.1,73,454/- in this financial year from previous year's balance, total of which is Rs.30,15,497/-. Thus, a sum of Rs.22,11,376/- was therefore available with her to meet out the household expenditure of her family consisting three members in the both of the financial years.

It is pertinent mention here that officer's husband is also Judicial Officer having annual income of Rs.28,00,968/- in each financial years.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial year 2016-18(2016-17 & 2017-18). which has already been seen Hon'ble Mr. Justice Ramesh Sinha, the then, Administrative Judge, Ghaziabad, in the Misc. file of the officer. And for the property statement of the financial years 2018-20, a detailed note has been submitted before Hon'blr Mr. Justice Ashutosh Srivastava, Administrative Judge, Hapur for His Lordship's kind perusal & order on eService ID P00009912021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 08.12.2022. As such, there is no delay in submitting the same.
