May kindly see the property statement online received from Smt. Anjum Saifi, Civil Judge (Senior Div.), Mirzapur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 & 2021-22), her gross income from salary is Rs.19,31,912/- and total deductions/Savings/investments against Savings in Bank account, NPS, GIS, Income Tax, Repayment of car loan and Insurances are Rs.13,83,249/-. The balance of Rs.1,81,088/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.5,48,663/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent mention here that's Officer's Husband (Advocate) annual income was Rs.2,50,000/- for the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00058932022 and same has been processed before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Mirzapur Judgeship for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide dated 21.12.2022 on eServicesJo portal. As such, there is no delay in submitting the same.
