May kindly see the property statement received online from Sri Anshuman Patnaik, Addl. District & Sessions Judge, Kanpur Nagar, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary, interest & arrears is Rs.18,34,900/- and total deductions/savings/investment against NPS, GIS, PPF, Insurances and Income Tax is Rs.6,16,244/- and the balance of his savings bank account(s) is also increased by Rs.8,05,329/- in this financial year from previous year's balance, total of which is Rs.14,21,573/-. Thus, a sum of Rs.4,13,327/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that his wife have average monthly income of Rs.20,000/- from part time counsellor (education and health).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id: P00005742021 (Old Case Id: 2626) and the same has been seen by Hon'ble Mr. Justice Vivek Chaudhary, the then Administrative Judge, Barabanki Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 04.01.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated in the remark column of movable proforma, that (in his verbatim):

"At the Time of Joining (21.03.2020) property statement had been submitted by me previously. Thereafter property statement for financial years 2020 - 2022 was submitted.

There was an inadvertent lapse on my part with regard to the financial year 2019- 2020 property statement as joining was on 21.03.2020, which is now being submitted.

I most humbly seek the kind condonation of the delay. I shall ensure in future that no such delay is caused.

I shall be highly obliged for this act of kindness."

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Anshuman Patnaik, Addl. District & Sessions Judge, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
