

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Sri Randheer Singh, Chairman, Commercial Tax Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2010-2012 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2010-2012 (2010-11 & 2011-12) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial year 2010-2012 (2010-11 & 2011-12)**, the Gross income is Rs.36,58,094/- (Rs.30,89,094/- from Salary, Rs.5,55,000/- from House Rent & Rs.14,000/- from SB Interest) and total deductions/savings/investment against GIS, GPF, PPF, SIPs, Mutual Funds, Insurances, Loan repayments and Income Tax is Rs.21,86,056/-. Thus, a sum of Rs.14,72,038/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2010-2012 (2010-11 & 2011-12) and the balance of his savings bank account(s) is also decreased by Rs.7,572/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife have annual income of Rs.60,000/- from Teaching & Boutique.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2008-2010 offline and the same has been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Kannauj Judgeship, in the misc file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2010-2012 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has firstly submitted movable and immovable property statements of the financial year 2010-2012 (2010-11 & 2011-12) vide online dated 20.12.2022. As such, there is delay in submitting the same for which the officer has stated that (in his verbatim) "*property statement for the years 2010-12, 2012-14, 2014-16 & 2016-18 have been submitted with the apology for delayed submission*", in the remark column of the property statement for the financial year 2020-2022 (Case Id : P00062132022).

May, therefore, if approved, property statements for the financial year 2010-2012 (2010-11 & 2011-12) of Sri Randheer Singh, Chairman, Commercial Tax Tribunal, Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
