In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary is Rs.47,12,634/and total deductions/Savings/investments NPS, GIS, Income Tax, Repayment of home loan, PPF, SIP and Insurances are Rs.27,40,749/-. The balance of Rs.2,36,656/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.22,08,541/- (Rs.19,71,885/- from salary and Rs.2,36,656/- from saving bank account withdrawal) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent to mention here that officer's wife (Advocate) having annual income was Rs.3,62,930/- for the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for for the financial years 2018-20 (2018-19 & 2019-20) online against P00003432021 (old case id-2358) and same has been processed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Ballia for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 21.12.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri. Mahesh Chandra Verma, Spl. Judge (E.C. Act), Ballia, be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Ballia, for His Lordship's kind perusal and orders?
