May kindly see the property statements online received from Smt. Neha Rungta, Additional Chief Judicial Magistrate, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2020-22, total income is Rs.25,46,235/- (total Gross income from salary are Rs.24,90,554/-, Income from interests of Rs.17,988/-, Capital gain of Rs.31,543/- and Dividend income of Rs.6,150/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, car loan, Insurance policies, PPF, ULIP and Mutual Fund are Rs.10,28,166/-. Thus, a sum of Rs.15,18,069/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.33,412/- this financial year from previous year's balance.

It is pertinent to be mention here that her husband as Assistant Audit Officer at CAG having annual income of Rs.5,63,079/- & Rs.10,45,484/- for the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into Judicial Service which had already been seen by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Ghaziabad on e-service ID no.P00054672022. And property statements of 2014-16, 2016-18 & 2018-20 has been processed on e-service ID nos. P00054682022, P00054692022 & P00054702022 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements for the financial years 2020-21 & 2021-22 vide online dated 18.12.2022. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Smt. Neha Rungta, Additional Chief Judicial Magistrate, Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
