May kindly see the property statements online received from Sri Avinash Kumar Singh, Additional District & Sessions Judge, Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross income is Rs.36,31,095/- and total deductions/ repayment/ savings/ investment against Income Tax, PPF a/cs, Insurance policies, NPS, PLI and FGLIC are Rs.13,09,451/-. Thus, a sum of Rs.23,21,644/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.10,93,422/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earns Rs.2,50,000/- per annum from House rent.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2016-17 which had already been seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Moradabad, in the misc. file of the officer. And statement of the financial years 2017-18 & 2018-19 has been processed online on e-service ID no.P00010862021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March, 2022. He has submitted movable and immovable property statements for the financial years 2019-20 & 2020-21 vide online dated 22.12.2022. As such, there is delay in submitting the same from the part of the officer for which he has not given any reason.

May, therefore, if approved, property statements for the financial years 2019-20 & 2020-21 of Sri Avinash Kumar Singh, Additional District & Sessions Judge, Jhansi be laid before Hon'ble Mrs. Justice Manju Rani Chauhan, Administrative Judge, Jhansi Judgeship for Her Lordship's kind perusal and orders?
