May kindly see the property statements online received from Sri Rajesh Bhardwaj, the then Additional District & Sessions Judge, Muzaffarnagar presently Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2014-15 & 2015-16 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below. (1) In the financial year 2014-15 & 2015-16, Total Income is Rs.25,70,414/- (income from salary is Rs.25,42,520/-, ITR of Rs.9,790/- and interest on FDR is Rs.18,104/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against LIP, GPF, GIS, Insurance policies, Home loan, Income Tax and the balance of his savings bank account(s) is enhanced for Rs.58,967/- this financial year from previous year's balance, total of which is Rs.13,36,625/-. Thus, a sum of Rs.12,33,789/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is Govt. Teacher having annual income of Rs.5,00,000/-.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Abhinava Upadhya, the then Administrative Judge, Muzaffarnagar in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements for the financial years 2014-15 firstly on 17.03.2016 in the misc. file of the officer & 2015-16vide online dated 21.03.2020. As such there is delay in submitting the property statement of the financial year 2015-16 for which he tenders his unconditional apology and stated that he could not submit property statement within time because after posting at Muzaffarnagar in May-2016, his mother detected cancer on 30.05.2016 and for the treatment, he got busy for the same but mother died in Feb-2018 Thereafter he became sick & ultimately in Dec-2018 he under went major abdominal surgery, mentioned in the remark column no.9 of movable statement.

May, therefore, if approved, property statements for the financial years 2014-15 & 2015-16 of Sri Rajesh Bhardwaj, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
