May kindly see the property statement received online from Sri Ram Kesh, Presiding Officer, Commercial Court, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and arrear is Rs.46,82,027/- and total deductions/savings/investment against GIS, GPF, PPF, Insurance, Income Tax and Car Loan repayment along with down payment are Rs.23,72,493/- and the balance of his savings bank account(s) is also increased by Rs.7,83,887/- in this financial year from previous year's balance, total of which is Rs.31,56,380/-. Thus, a sum of Rs.15,25,647/-was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his daughter, Junior Resident Doctor/Demonstrator, have gross salary Rs.78,764/- per month in the FY 2020-21 and 'NIL' in the FY 2021-22 as she had left the job.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00008522021 (Old Case Id : 2925) and the same has been seen by Hon'ble Mrs. Justice Sangeeta Chandra, the then Administrative Judge, Allahabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 18.12.2022. As such, there is no day delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Ram Kesh, Presiding Officer, Commercial Court, Prayagraj, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
