In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary and arrear is Rs.46,82,027/- and total deductions/savings/investment against GIS, GPF, PPF, Insurance, Income Tax and Car Loan repayment along with down payment are Rs.23,72,493/- and the balance of his savings bank account(s) is also increased by Rs.7,83,887/- in this financial year from previous year's balance, total of which is Rs.31,56,380/-. Thus, a sum of Rs.15,25,647/-was therefore available with him to meet out the household expenditure of his family consisting six members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that his daughter, Junior Resident Doctor/Demonstrator, have gross salary Rs.78,764/- per month in the FY 2020-21 and 'NIL' in the FY 2021-22 as she had left the job.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00008522021 (Old Case Id: 2925) and the same has been seen by Hon'ble Mrs. Justice Sangeeta Chandra, the then Administrative Judge, Allahabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 18.12.2022. As such, there is no day delay in submitting the same.
