May kindly see the property statement online received from Sushri Mukta Tyagi, Additional Chief Judicial Magistrate, Agra regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2018-20 (2018-19 & 2019-20). Gross income from salary is Rs.19,66,161/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF and the balance of her savings bank account(s) is also enhanced by Rs.5,81,836/- in this financial year from previous year's balance, total of which is Rs.11,92,681/-. Thus, a sum of Rs.7,73,480/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the both of the financial.

It is pertinent mention here that Officer's father (Agriculture) having annual income was Rs.2,00,000 to 2,50,000( not fixed).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2016-18 (2016-17 & 2017-18) online against case id- P00000102023 and same has been processed before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2021 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 21.12.2022. As such, there is delay in submitting the same. In this regard, officer has stated that delayed due to Covid-19.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sushri Mukta Tyagi, Additional Chief Judicial Magistrate, Agra be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra for His Lordship's kind perusal and orders?
