May kindly see the property statement received online from Sri Shobit Bansal, Additional Civil Judge (Sr.Div.)/ACJM., Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.21,03,010/- and total deductions/savings/investment against NPS, GIS, Income Tax, LIC, PPF, Health Insurance, Term plan, mutual funds and the balance of his savings bank account is also enhanced by Rs.4,40,398/- in this financial year from previous year's balance, total of which is Rs.10,67,794/-. Thus, a sum of Rs.10,35,216/- was therefore available with him to meet out the household expenditure of his family consisting three members in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statements held at the time of entering into U.P. Judicial Service & for the the financial year 2016-17 & 2017-18 which has been seen by Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then Administrative Judge, Baghpat Judgeship, in the misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted his movable and immovable property statement for the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 01.01.23. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has stated (in his verbatim) that "Applicant could not submit the above statement within time due to illness of his father and unavailability of data of bank and other funds. For delay applicant apologizes. Kindly accept property statement for the financial year 2018-19 & 2019-20."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Shobit Bansal, Additional Civil Judge (Sr.Div.)/ACJM., Rampur be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Rampur Judgeship for His Lordship's kind perusal and orders?
