Thus, a sum of Rs.18,90,424/- was therefore available with her to meet out the household expenditure of her family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of her savings bank account is also decreased by Rs.28,434/- in this financial year from previous year's balance.

It is also pertinent to mention here that the her husband is a Judicial Officer having annual income of Rs.20,93,637/- & Rs.21,47,090/- in the both financial year respectively.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20), online against Case Id: P00009852020 (Old Case Id: 1889) and the same has been seen by Hon'ble Mr. Justice Ashwani Kumar Mishra, the then Administrative Judge, Aligarh Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 03.01.2023. As such, there is no delay in submitting the same.
