May kindly see the property statement received online from Sri Anil Kumar-VI, Special Judge (SC/ST, Pev.of Atroci Act), Fatehpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income from salary is Rs.41,57,741/- and total deductions/savings/investment against GIS, NPS, PPF, Insurances, FD, Mutual Fund, loan repayments and Income Tax is Rs.28,87,973/-. Thus, a sum of Rs.12,69,768/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22) and the balance of his savings bank account(s) is also decreased by Rs.2,59,005/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00007412021 (Old Case Id : 2807) and the same has been seen by Hon'ble Mr. Justice Narendra Kumar Johari, the then Administrative Judge, Fatehpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 24.11.2023. As such, there is delay in submitting the same from the part of officer for which he has stated in his online reply dated 12.09.2024, that *"I was transferred from Hardoi to Fatehpur as per notification of Hon'ble Court in July-2022. Though I had already drafted property statement for the year 2020-2022 on 28-12-2022, whereas some data regarding salary account & home loan account were to be collected from different districts to add in the statement. In above circumstances and also due to engagement in judicial work delay caused on time submission for which I seek apology to the Hon'ble Court."*

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Anil Kumar-VI, Special Judge (SC/ST, Pev.of Atroci Act), Fatehpur, be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Fatehpur Judgeship for His Lordship's kind perusal and orders?
