May kindly see the online property statement received from Sri Narendra Pal Rana, Additional District & Sessions Judge, Ballia presently suspended since 25.05.2023 (attached to Etah headquarter) regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income is Rs.33,06,764/- [Gross Income from salary is Rs.30,89,052/- and income from other sources (STCG from Mutual Fund, LTCG from Mutual Fund, LIC, House Rent, Dividend & Bank interest) are Rs.33,06,764/-] and total deductions/ repayment/ savings/ investment against GIS, Insurance policies, Income Tax, CPF/NPS, PPF, Car loan, Home loans, NSC and the balance of his savings bank account(s) has also been enhanced for Rs.1,69,360/- this financial year from previous year's balance, total of which is Rs.14,44,957/-. Thus, a sum of Rs.18,61,807/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that his wife is also a Judicial Officer having monthly income of Rs.1,33,684/- and Rs.1,61,482/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2014-15 which had already been seen by Hon'ble Mr. Justice Pankaj Mithal, the then Administrative Judge, Lucknow and a detailed offline note regarding property statement of the financial years 2015-17 has been laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 05.01.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated (in his verbatim) that *"For the period 2017-18 I submitted property statement offline and for the period 2018-19 and 2019-20 via online. When I submitted property statement for period 2018-20 as per two year block policy via online mode then objection was raised that as per two year block policy I have to submit statement for period 2017-19 (two year block). So I submitted new property statement in online mode 2017-19 (for two years). So it was late due to mistake of fact in calculating two year block. I am extremely sorry if any delay is caused at my end in submission of property statement and will keep myself aware for future submissions."*, mentioned in attachment dated 13.01.2024.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Narendra Pal Rana, Additional District & Sessions Judge, Ballia presently suspended since 25.05.2023 (attached to Etah headquarter) be laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
