May kindly see the property statement online received from Sri Punit Kumar Gupta, Addl. District & Sessions Judge, Moradabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Total income is Rs.31,73,700/- (Gross income from salary ) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, Insurances, are Rs.20,25,315/-. Thus, a sum of Rs.11,48,385/- was available with him to meet out the household expenditure of his family consisting five members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.3,23,174/- this financial year from previous year's balance.

It is pertinent to mention here that wife of the officer is an Advocate & her income is approx Rs.2,00,000/- per annual.

In this connection, it is submitted that the officer has already submitted his property statements—upto financial years 2015-16 which has already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Kanpur Nagar in the Misc. file of the officer concerned.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online dated 06.01.2023. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has stated that he could not submit the property statement in time due to his mother's Cancer treatment, for which he has regretted & assured that same will not be happened in future, mentioned in attachment letter dated 05.01.2023.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Punit Kumar Gupta, Addl. District & Sessions Judge, Moradabad be laid before Hon'ble Mr. Justice Dinesh Kumar Singh, Administrative Judge, Moradabad for His Lordship's kind perusal and orders?
