May kindly see the online property statements received from SriNarendra Pal Rana, Additional District & Sessions Judge, Ballia presently suspended since 25.05.2023 (attached to Etah headquarter) regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-20 & 2020-21, Total income is Rs.37,54,763/- [Gross Income from salary is Rs.35,61,748/- and income from other sources (Rental income, Dividend, Bank interest, FD encashed & LIC) are Rs.1,93,015/-] and total deductions/ repayment/ savings/ investment against GIS, Income Tax, CPF/NPS, PPF, Home loans, LIC and shares are Rs.18,44,150/-. Thus, a sum of Rs.19,10,613/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.71,886/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is also a Judicial Officer having monthly income of Rs.1,70,422/- and Rs.1,74,038/- in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2014-15 which had already been seen by Hon'ble Mr. Justice Pankaj Mithal, the then Administrative Judge, Lucknow and a detailed offline note regarding property statement of the financial years 2015-17 has been laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer. Office notes regarding property statements of the financial years 2017-19 has been submitted online before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.
