May kindly see the online property statements received from Sri Vikas Nagar, Additional District & Sessions Judge (POCSO), Gautam Buddha Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.52,13,096/- (total Gross is Rs.45,38,096/- and sale of ancestral property of Rs.6,75,000/-) and total deductions/ repayment/ savings/ investment against CPF, GIS, Income Tax, PPF a/c, Gold bond, FD, Mutual Fund, NSC, shares, saving bond, FD and the balance of his savings bank account(s) has also been enhanced for Rs.6,06,171/- this financial year from previous year's balance, total of which is Rs.40,18,434/-. Thus, a sum of Rs.11,94,662/- was therefore available with him to meet out the household expenditure of his family consisting of four members for both the financial years 2020-21 & 2021-22.

It is pertinent to mention here that his wife is also Additional District & Sessions Judge having annual income of Rs.20,92,522/-.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Lucknow, placed in the misc. file of the officer. Detailed online note has been laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautam Buddha Nagar Judgeship for His Lordship's kind perusal and orders for the property statements of the financial years 2018-20, on eService ID P00001872020

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 20.01.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-21 & 2021-22 of Sri Vikas Nagar, Additional District & Sessions Judge (POCSO), Gautam Buddha Nagar be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautam Buddha Nagar Judgeship for His Lordship's kind perusal and orders?
