May kindly see the property statement online received from Sri Vijay Kumar Verma-I, Additional District & Sessions Judge, Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 & 2021-22), Total income is Rs.46,46,617/- (Gross income from salary is Rs.46,31,305/- and interest on savings a/c of Rs.15,312/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF/PRAN, GIS, Income Tax, LIC, PPF, Mutual funds, Home loan and Car loan are Rs.30,16,965/-. Thus, a sum of Rs.16,29,652/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,04,097/- this financial year from previous year's balance. It is also pertinent to mention here that his wife earned Rs.22,000/- and Rs.25,000/- approx./month in the financial years 2020-21 & 2021-22 respectively, from Coaching/Teaching.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 which had already been seen, online against Case Id: P00005542021 (Old Case Id: 2603), by Hon'ble Mr. Justice Neeraj Tiwari, the then Administrative Judge, Jhansi Judgeship

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) firstly, vide online dated 07.02.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Vijay Kumar Verma-I, Additional District & Sessions Judge, Jhansi be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
