May kindly see the online property statements received from Sri Vikas Goyal, Special Judge (E.C.Act), Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Total Gross income from salary with allowances are Rs.53,53,681/- (including bank interests of Rs.73,344/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC policies and the balance of his savings bank account(s) has enhanced for Rs.7,04,701/- this financial year from previous year's balance, total of which is Rs.23,68,853/-. Thus, a sum of Rs.29,84,828/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements upto the the financial years 2017-18 which had already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Kanpur Nagar, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 firstly vide offline dated 29.08.2019 and 2019-20 online on 25.01.2023. As such, there is delay in submitting the property statement of the financial year 2019-20 from the part of the officer for which he has stated (in his verbatim) that "I extremely apologise for late Submission of my property statement for financial year 2018-19 and 2019-2020. In year 2021, I got two transfers and myself and all my family members including my wife, both children and parents suffered from Covid-19 disease. In future I will take all care to submit my property statement within time. I pray to The Hon'ble Court to Kindly exonerate the delay making me highly obliged", mentioned in his reply dated 24.08.2024.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Sri Vikas Goyal, Special Judge (E.C.Act), Kanpur Nagar be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
