May kindly see the online property statements received from Sri Vikas Goyal, Special Judge (E.C.Act), Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total Gross income from salary with allowances are Rs.42,95,386/- (including bank interests of Rs.1,14,022/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF and LIC policies are Rs.13,42,437/-. Thus, a sum of Rs.29,52,949/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.86,183/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements upto the the financial years 2017-18 which had already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Kanpur Nagar, placed in the misc. file of the officer. And property statement of the financial years 2018-20, a detailed online note has been laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders on eService ID P00000352023.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 25.01.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 of Sri Vikas Goyal, Special Judge (E.C.Act), Kanpur Nagar be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
