In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 & 2021-22), total income is Rs.38,52,577/- (total Gross salary is Rs.37,02,577/- and rental income of Rs.1,50,000/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, Bond, FD, Mutual Fund and the balance of his savings bank accounts has been enhanced for Rs.3,32,199/- this financial year from previous years balance, total of which is Rs.35,92,681/-. Thus, a sum of Rs.2,59,896/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years.

It is pertinent to mention here that her husband is also Additional District & Sessions Judge having annual income of Rs.24,00,000/-. And statement of the financial year 2020-22 of her husband has also been submitted separately on eService ID P00000172023.

In this connection, it is submitted that the Officer has already submitted her property statements of the Financial year 2018-20 online and same has been approved online by Hon'ble Mr. Justice Neeraj Tiwari, the then, Administrative Judge, Jhansi.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 24.03.2023. As such, there is no delay in submitting the same.
