May kindly see the property statements online received from Sri Rajesh Bhardwaj, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial year 2016-17 & 2017-18, Total Income is Rs.33,58,302/- (Gross salary is Rs.33,14,450/-, IT refund of Rs.8,852/- and PPF withdrawal of Rs.35,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against LIP, GPF, GIS, Insurance policies, Home loan, Income Tax and PPF a/c are Rs.21,92,903/-. Thus, a sum of Rs.11,65,399/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.62,243/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is Govt. Teacher having annual income of Rs.7,00,000/-.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Muzaffarnagar in the misc. file of the officer. And property statements of the financial years 2014-16 has been processed on Statement ID no.879.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 firstly vide online dated 30.05.2020. As such there is delay in submitting the property statement of the financial year 2016-18 for which he has stated that "In Dec.2018, he under went major abdomen surgery and after recovery from surgery, he submitted property statement on dated 20.03.2020. Section Admin-A4 raised preliminary objection as to the 2 years current block period and as per objection resubmitting these property statement. Delay in submitting these property statement is due to Covid-19 situation. He tenders his unconditional apology for the same" mentioned in his reply dated 23.02.2021.

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Rajesh Bhardwaj, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
