May kindly see the property statement submitted online received from 2020 - 2022 (2020-21 and 2021-2022) from Sri Abhinav Tiwari, Additional Chief Judicial Magistrate, , Pilibhit regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020 - 2022 (2020-21 and 2021-2022) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2020 - 2022 (2020-21 and 2021- 2022) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2020 - 2022 (2020-21 and 2021- 2022), his Total income from salary is Rs.30,83,268/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, repayment of loans, LIC, SIP and the balance of his Saving bank A/c(s) is enhanced for Rs.1,27,177/- this financial year from previous year's balance, total of which is Rs.17,53,667/-. Thus a sum of Rs. 13,29,601/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his father's and mother's income are Rs. 8 lac and 6 lac respectively and his wife is also self employed. Her annual income is Rs. 3.5 lac approx.

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2018-20 which had already been seen by Hon'ble Mr. Justice Shekhar Kumar Yadav, the then Administrative Judge, Pilibhit on e-service old Case Id no.3490.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial years 2020 - 2022 (2020-21 and 2021 - 2022) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020 - 2022 (2020-21 and 2021 - 2022) firstly vide his application dated 02.02.2023. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2020 - 2022 (2020-21 and 2021-2022) of Sri Abhinav Tiwari, Additional Chief Judicial Magistrate, Pilibhit be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit for His Lordship's kind perusal and orders?
