May kindly see the property statement online received from Sri Arvind Malik, Chairman, Commercial Tax Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income is Rs.52,45,463/- (Rs.51,90,602/- from salary and Rs.54,861/- from other sources) and total deductions/savings/ investment against CPF, GIS, Income Tax, GVR, Repayment of loan and Insurances is Rs.28,60,380/-. Thus a sum of Rs.29,11,978/- (Rs.23,85,083 from salary and Rs.5,26,895/- from saving bank accounts) was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial year 2020-22 (2020-21 & 2021-22) and the balance of his savings account is also decreased for Rs.5,26,895 /- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2018-20 (2018-19 & 2019-20) online against case-id P00001722021 (old case id-2156), which had been seen by Hon'ble Mr. Justice Subhash Chand, the then, Administrative Judge, Shamli.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-22 (2020-21 & 2021-22) vide online dated 14.02.2023. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Arvind Malik, Chairman, Commercial Tax Tribunal, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
