May kindly see the property statement online received from Smt. Manisha, presently suspended since 25.05.2023, and attached to the Etah headquarter, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 and 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 and 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2020-22 (2020-21 and 2021-22), her gross income from salary and other sources are Rs.52,92,146/- (Rs.43,22,318/- from salary, Rs.5,22,826/- form maturity of LIC policy, Rs.3,31,502/- from maturity of PPF account and Rs.1,15,500/- from rental income) and total deductions/Savings/investments GPF, GIS, Income Tax, Mutual Funds, Repayment of loans and Insurances are Rs.34,53,311/-. The balance of Rs.7,25,669/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.18,38,835/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2020-22 (2020-21 and 2021-22).

It is to pertinent mention here that officer's husband (Judicial Officer, Uttar Pradesh) having annual income was Rs.19,14,873/- for the financial year 2020-21 and Rs.21,65,076/- for the financial year 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2018-20 (2018-19 and 2019-20) online against case id-P00010662021 (old case id-3156) and same has been processed before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 and 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She had submitted movable and immovable property statements for the financial years 2020-22 (2020-21 and 2021-22) vide online dated 21.02.2023 on eServicesJo portal. As such, there is no delay in submitting the same.
