May kindly see the online property statement received from Sri Padam Narain Mishra, the then District and Sessions Judge, Ambedkar Nagar presenyly posted as District and Sessions Judge, Jhansi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years financial years 2020-21 & 2021-22 (financial year 2020-22) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2020-21 & 2021-22 (financial year 2020-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below. (1) In the financial years 2020-21 & 2021-22 (financial year 2020-22), total income from Salary is Rs.48,79,930/- and total deductions/ repayment/ savings/ investment (for both the financial years) against CPF/NPS, GIS, Income Tax, car loan, Home loan, Insurance policies and SIP are Rs.32,43,908/-. Thus, a sum of Rs.16,36,022/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,14,055/- this financial year from previous year's balance.

It is pertinent to mention here that his wife's annual income is Rs.4,78,290/- & Rs.4,85,200/- from Business & Advisor (Astrology) in the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining which had already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Banda and property statement for the financial years 2008-09 to 2013-14 had already been laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Ambedkar Nagar for His Lordship's kind perusal & order, in the misc. file of the officer. Online detailed office note related to property statement of the financial years 2014-16, 2016-18 & 2018-20 has already been submitted on eservice IDs 4987, 5013 & 5043 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in the next financial year i.e., 2022-23 upto March 2023. Officer has submitted the same firstly on 16.03.2023. As such, there is no delay in submitting the same.
