

## **Registrar (Judicial) (Budget)**

May kindly see the online property statements received from Sri Krishna Kumar-V, Additional District & Sessions Judge, Allahabad (Prayagraj) regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), total income is Rs.44,51,714/- (annual income from salary & arrear are Rs.40,69,887/-, leave encashment of Rs.1,51,557/- and interests of SB a/c of Rs.2,30,270/-) and total deduction/ repayment/ savings/ investment/ against GIS, GPF, PPF a/c, Income Tax, Insurance policies and the balance of his savings bank account(s) is enhanced for Rs.11,00,778/- this financial year from previous year's balance, total of which is Rs.28,45,648/-. Thus, a sum of Rs.16,06,066/- was available with him to meet out the household expenditure of his family consisting four members for both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2018-20 which had already been seen online by Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then Administrative Judge, Allahabad.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e. 2022-23 upto March,2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) firstly vide online dated 18.02.2023. As such, there is no delay in submitting the aforesaid property statements.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Krishna Kumar-V, Additional District & Sessions Judge, Allahabad (Prayagraj) be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad for His Lordship's kind perusal and orders?
