May kindly see the property statement received online from Sri Prashant Mishra-II, Addl. Civil Judge (Sr.Div.)/ACJM., Amroha regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2016-2018 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2016-2018 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2016-2018 (2016-17 & 2017-18), the Gross income from salary is Rs.9,66,689/- and total deductions/savings/investment against GIS, NPS, Loan repayments, Insurances and Income Tax is Rs.2,78,673/-, and the balance of his savings bank account(s) is also increased by Rs.3,48,800/- in this financial year from previous year's balance, total of which is Rs.6,27,473/-. Thus, a sum of Rs.3,39,216/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2016-2018 (2016-17 & 2017-18).

It is pertinent to mention here that his wife have annual income of Rs. 3 to 4 lakhs Approx. from Business.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining into U.P. Judicial Service online against Case Id: P00002572024 and the same has been processed before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-2018 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18) vide online dated 30.05.2023. As such, there is delay in submitting the same from the part of officer, for which he stated in the remark column, that:

"The delay was caused by a combination of factors, including mandatory Induction training for 6 months in two phases that required my attention, meanwhile a sudden transfer to a new location, and some unavoidable circumstances that arose unexpectedly. Although I did my best to complete the task on time, these events made it challenging to meet the deadline.

Please know that I deeply regret any inconvenience or frustration that this delay may have caused. I understand the importance of complying with deadlines and regulations and assure you that I take this matter seriously. To rectify the situation, I have submitted the property statement as soon as possible and have taken steps to ensure that I will not encounter similar challenges in the future. Once again, I apologize for any inconvenience that my actions may have caused."

May, therefore, if approved, property statements for the financial year 2016-2018 (2016-17 & 2017-18) of Sri Prashant Mishra-II, Addl. Civil Judge (Sr.Div.)/ACJM., Amroha, be laid before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders?
