May kindly see the property statement online received from Sri Satya Deo Gupta, Additional District & Sessions Judge, Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary and other sources are Rs.50,26,673/- (Rs.45,48,292/- from salary, Rs.48,372/- from maturity of LIC, Rs.1,30,009/- from Interest against saving bank accounts deposits and Rs.3,00,000/- from gift) and total deductions/Savings/investments against Deposits in Saving Bank Account, GPF, GIS, Income Tax, Insurances, PPF, RD, Home loan repayment are Rs.44,28,080/-. The balance of Rs.15,88,320/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.5,98,593/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2020-22 (2020-21 & 2021-22).

It is pertinent to mention here that officer's wife (advocacy) annual income was Rs.4,00,000/- for the financial years 2020-21 & 2021-22 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00004592020 (Old Case Id: 1175), which has already been seen by Hon'ble Mr. Justice Alok Singh, the then Administrative Judge, Bareilly.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 01.03.2023. As such, there is no delay submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Satya Deo Gupta, Additional District & Sessions Judge, Hardoi be laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Hardoi Judgeship for His Lordship's kind perusal and orders?
