

**Registrar (Judicial) (Budget)**

May kindly see the online property statements received from Sri Pankaj Misra, Additional Principal Judge, Family Court, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

1. In the financial years 2020-22 (2020-21 & 2021-22), total income is Rs.49,48,037/- (Gross Income from salary of Rs.48,52,943/-, L&T bond maturity amount of Rs.21,640/-, IDFC bond maturity of Rs.43,454/- and matured amount of policy of Rs.30,000/-) and total deduction/ repayment/ savings/ investment/ against NPS, GIS, GPF, PPF, Income Tax, LIC policies, PLI, Mutual Fund, SBI life policy, FDR and Home loan are Rs.36,44,788/-. Thus, a sum of Rs.13,03,249/- was available with him to meet out the household expenditure of his family consisting five members for both the financial years. The balance of his savings bank account(s) is also reduced for Rs.1,75,436/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2018-20 which had already been seen online by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Meerut on e-Service ID 2367.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e. 2022-23 upto March, 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 03.03.2023. As such, there is no delay in submitting the aforesaid property statements.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Pankaj Misra, Additional Principal Judge, Family Court, Mau be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Mau for His Lordship's kind perusal and orders?
