May kindly see the property statement received online from Sri Aditya Chaturvedi, A.D.J. (POCSO), Kasganj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), his income from salary & arrears is Rs. 40,35,596/- and from mutual fund redemption/surrender of LIC policy/pre-matured FD is Rs.47,32,497/-, total of which is Rs.87,68,093/-. And total deductions/savings/investment against GIS, NPS, Income Tax, PPF, LIC, Mutual fund, F.D., purchase of jewellery and the balance of his savings bank account is also enhanced by Rs.82,303/- in this financial years from previous year's balance, total of which is Rs.70,46,778/-. Thus, a sum of Rs.17,21,315/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has submitted his property statements upto the financial years 2018-20 and the same has already been seen online against Case Id: P00000572021 by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Lucknow Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 14.03.23. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Aditya Chaturvedi, A.D.J. (POCSO), Kasganj be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Kasganj Judgeship for His Lordship's kind perusal and orders?
