May kindly see the property statement received online from Sri Prakash Nath Srivastava, Presiding Officer, Motor Accident Claims Tribunal, Bhadohi at Gyanpur, regarding submission of complete statement of movable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2020-2022 (2020-21 & 2021-22), the Gross salary is Rs. 51,30,650/- and total deductions/savings/ investment against GPF, GIS, Car loan repayment, Income Tax, Insurances is 26,88,398/- and the balance of his savings bank account(s) is also enhanced by Rs. 3,74,684/- in this financial year from previous year's balance, total of which is Rs.30,63,082/-. Thus, a sum of Rs. 20,67,568/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

It is pertinent to mention here that the officer's wife income was Rs.3,00,000/- annually in the financial year 2020-2022 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2018-20 (2018-19 & 2019-20) online against Case Id : P00017532021 (Old Case Id :3872) and the same has been processed before Hon'ble Mr. Justice Mohd. Azhar Husain Idrisi, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 04.03.2023. As such, there is no delay in submission.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Prakash Nath Srivastava, Presiding Officer, Motor Accident Claims Tribunal, Bhadohi at Gyanpur, be laid before Hon'ble Mr. Justice Mohd.
