May kindly see the online property statements received from Sri Mohit Nirwal, Additional Civil Judge (Jr. Div.), Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2019-21 (13.12.2019 to 31.03.2020) & 2020-21, Total income is Rs.12,23,141/and total deductions/ repayment/ savings/ investment against NPS, Income Tax, PPF, Car loan and the balance of his savings bank account(s) has been enhanced for Rs.28,750/- this financial year from previous year's balance, total of which is Rs.8,89,402/-.Thus, a sum of Rs.3,33,739/- was therefore available with him to meet out the household expenditure of himself in one year three months of the financial years 2019-20 & 2020-21 .

In this connection, it is submitted that officer has submitted his property statement at the time of joining into Judicial service which has been laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders on e-service ID P00001062021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements for the financial years 2019-20 & 2020-21 firstly vide online dated 15.03.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he has not delayed the submission of the property statement for the period April,2019 to March,2021 deliberately. The delay caused is inadvertent, for which he convey sincere apologies and undertakes to adhere to timely submission of the same in near future", mentioned in attachment "cover letter" dated 09.03.2023.

May, therefore, if approved, property statements for the financial years 2019-20 & 2020-21 of Sri Mohit Nirwal, Additional Civil Judge (Jr. Div.), Jalaun at Orai be laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Jalaun at Orai Judgeship for His Lordship's kind perusal and orders?
