May kindly see the property statement submitted online received from Sri Vivek, presently posted as Presiding Officer, Motor Accident Claim Tribunal, Hapur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer Sri Vivek, presently posted as Presiding Officer, Motor Accident Claim Tribunal, Hapur concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary, arrears and other sources is Rs. 58,39,410/- (including Rs. 5,000/- received from LIC policy as survival benefits, 20,000/- for S.B. Interest, 13,580/- Refund from IT, 19,170 IT return by cheque, 270,102/- FD closed, 4,74,275/- FDR closed, 30,324/- NSC matured, 52,329/- (-), 4,11,442/- SBI bond fund credited) and total deductions/savings/investments against GIS, NPS, Insurances, Income Tax, TDS, PPF, LIC, NSC, SIPs, Bonds, and Funds is Rs. 45,11,660 (including enhancement of Rs. 68,554 in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 13,27,750/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline for financial years 2015-17 (2015-16 & 2016-17) which is seen by Hon'ble Ms. Justice Rakesh Srivastava, the then Administrative Judge, Agra.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online application dated 20.05.2020. As such, there is some delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Vivek, presently posted as Presiding Officer, Motor Accident Claim Tribunal, Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur for Her Lordship's kind perusal and order?
