May kindly see the property statement received online from Sri Yogesh Kumar Chaudhree, Civil Judge (Junior Div.), Utraula- Balrampur, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2019-2021 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2019-2021 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2019-2021 (2019-20 & 2020-21), the Gross income from salary is Rs.13,06,939/- and total deductions/savings/investment against NPS, GIS, PPF, Insurances, RD and Income Tax is Rs.3,06,597/- and the balance of his savings bank account(s) is also increased by Rs.56,942/- in this financial year from previous year's balance, total of which is Rs.3,63,539/-. Thus, a sum of Rs.9,43,400/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2019-2021 (2019-20 & 2020-21).

It is pertinent to mention here that his father (died on 24.07.2020) received Rs.24,000/- per month from pension till his death and his mother also received Rs.15,000/- per month from pension.

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of joining online against Case Id : P00032342021 (Old Case Id : 5378) and the same has been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Kanpur Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-2021 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-2021 (2019-20 & 2020-21) vide online dated 24.03.2023. As such, there is delay in submitting the same from the part of the officer for which he has stated in the remark column of movable proforma, that (in his verbatim) *"due to certain unavoidable reasons and due to misplacement of certain bank and loan related documents, the same could not be sent earlier, for which I convey my sincere apologies and undertakes to adhere to timely submissions of the same in the near future."*

May, therefore, if approved, property statements for the financial year 2019-2021 (2019-20 & 2020-21) of Sri Yogesh Kumar Chaudhree, Civil Judge (Junior Div.), Utraula- Balrampur, be laid before Hon'ble Mr. Justice Ram Manohar Narayan Mishra, Administrative Judge, Balrampur Judgeship for His Lordship's kind perusal and orders?
