May kindly see the property statement online received from Sri Kshitij Kumar Srivastava, Registrar (J)(Enquiry), High Court of Judicature at Allahabad regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), his gross income from salary and maturity of SBI Smart ULIP is Rs.65,39,532/- (Rs.11,47,088/- against maturity of SBI Smart ULIP) and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, PPF, Repayment of home is Rs.27,23,919/-. The balance of Rs.2,11,513/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.40,27,126/- (Rs.38,15,613/- from salary and Rs.2,11,513/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2020-22 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2018-20 (2018-19 & 2019-20) online against case id-P00025192021 (old case id-4652) and same has been processed before Hon'ble the Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide dated 01.04.2023. As such, there is no delay delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Kshitij Kumar Srivastava, Registrar (J)(Enquiry), High Court of Judicature at Allahabad be laid before Hon'ble the Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
