May kindly see the property statements received from Sri Ram Chandra Yadav-I, Additional District & Sessions Judge, Shravasti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-21 & 2021-22 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-21 & 2021-22 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-21 & 2021-22, Total income is Rs.46,74,160/- (income from salary is Rs.44,25,672/-, interest of SBI a/c of Rs.45,788/-, rent of Rs.1,69,200/- and agricultural income of Rs.33,500/-) including arrears & all allowances) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, PPF, LIC policies, RD, PLI and loan of Rs.23,49,741/-. Thus, a sum of Rs.23,24,419/-/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,75,720/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2018-20 online which had already been seen online by Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad on e-service portal vide statement ID 7191.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2020-21 & 2021-22 in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-21 & 2021-22 vide online dated 27.03.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2020-21 & 2021-22 (2020-22) of Sri Ram Chandra Yadav-I, Additional District & Sessions Judge, Shravasti be laid before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Shravasti Judgeship for His Lordship's kind perusal and orders?
