May kindly see the property statement received online from Sri Vineet Chaudhary, Additional District & Sessions Judge, Bulandshahar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), his total income is Rs.46,01,140/- (from Salary & allowances Rs.45,11,140 agricultural income Rs.90,000/-) and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, LIC, SBI policy, payment for car purchase & car loan is Rs.34,82,326/-. Thus, a sum of Rs.11,18,814/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both of the financial years. And the balance of his savings bank account(s) is also reduced by Rs.8,53,816/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2018-20 and the same has been seen online against Case Id : P00007182020 by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Gautam Budh Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) online on 28.03.23, which was forwarded by the District Judge on 14.04.2023, as informed by the officer in his reply dated 27.03.2024. As such, there is no delay in submitting the same, from the part of the officer.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Vineet Chaudhary, Additional District & Sessions Judge, Bulandshahar be laid before Hon'ble Mr. Justice J.J. Munir, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal and orders?
