May kindly see the online property statements received from Sri Ranjeet Kumar, Special Judge (SC/ST, Pev. Of Atroci Act), Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2020-22 (2020-21 & 2021-22), Total income is Rs.43,79,611/- (total Gross Salary are Rs.43,40,667/- and income from interest is Rs.38,944/-) and total deductions/savings/investments against NPS, GIS, Income Tax, Car loan, Insurance policies, P.P.F. a/c and NSC are Rs.16,86,186/-. Thus, a sum of Rs.26,93,425/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years. And the balance of his savings bank accounts has also been reduced for Rs.2,82,613/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements for the financial years 2018-20 online which was already been seen online by Hon'ble Mr. Justice Dinesh Kumar Singh, the then Administrative Judge, Moradabad with the warning issued to the officer to be careful in future while submitting the property statements in time as submission of property statement is not a mere farce formality, but is a predominant requirement of Government Servants Conduct Rules..

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide his online application dated 30.03.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Ranjeet Kumar, Special Judge (SC/ST, Pev. Of Atroci Act), Jaunpur be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur for His Lordship's kind perusal and orders?
