May kindly see the property statement received online from Sri Vinod Singh Rawat, Principal Secretary(Law) & L.R., Government of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2020-2022 (2020-21 & 2021-22), the Gross income is Rs.63,13,887/- (Rs.62,79,131/- from salary and Rs.34,756/- from Bank Interest) and total deductions/savings/investment against GIS, NPS, Insurances, CGHS, Loan repayments and Income Tax is Rs.27,62,577/- and the balance of his savings bank account(s) is also increased by Rs.2,36,858/- in this financial year from previous year's balance, total of which is Rs.29,99,435/-. Thus, a sum of Rs.33,14,452/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2020-2022 (2020-21 & 2021-22).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id : P00005082021 (Old Case Id : 2548) and the same has been seen offline by Hon'ble the then Chief Justice on 31.01.2023, placed in the Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 30.03.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Sri Vinod Singh Rawat, Principal Secretary(Law) & L.R., Government of U.P., Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
