May kindly see the online property statements received from Sri Bharat Singh Yadav, Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), total income is Rs.42,43,566/- and total deduction/ repayment/ savings/ investment/ against GIS, NPS, PPF a/c, Income Tax, LIC policies, RD, PLI and TDR are Rs.34,13,555/-. Thus, a sum of Rs.8,30,011/- was available with him to meet out the household expenditure of his family consisting seven members for both the financial years. And the balance of his savings bank account(s) has also been reduced for Rs.6,77,290/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2017-18, which has already been seen by Hon'ble Mr. Justice B.Amit Sthalekar, the then Administrative Judge, Kasganj with the direction that the officer be asked to submit property statement in time in future, placed in the misc file of the officer. And for the property statement of the finincial year 2018-20, a detailed note has been laid online before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders on eService ID P00011562021.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e. 2022-23 upto March,2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) firstly vide online dated 30.03.2023. As such, there is no delay in submitting the aforesaid property statements.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Bharat Singh Yadav, Additional District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
