May kindly see the property statement submitted online by Sri Kamala Pati-II, A.D.J. (FTC), Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary is Rs.33,69,736/- and total deductions/savings/ investment against NPS, GIS, PPF, LICs SBI MFSI, Income Tax, Repayment of home loan is Rs. 22,10,464/- (including enhancement of Rs. 5,995/- in his S.B. A/cs against the balance of the previous year) Thus a sum of Rs.11,59,272/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both the financial years.

In this connection, it is submitted that the Officer has already submitted his property statement of financial year 2018-20, which has been already seen by Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar, online against Case Id : P00039212021 (Old Case Id : 6069).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted movable and immovable property statements of the financial years 2020-22 (2020-21 & 2021-22) vide online dated 02.04.2023. As such, there is delay (of two days only) in submitting the same for which he has stated - "due to his mother's sickness (suffering from severe Asthma) and his father's brain haemorrhage attack condition, he could not submit his property statements for the financial year 2020-21 & 2021-22 in time and requested to condone the delay", as mentioned in his attachment dated 31.03.2023.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Kamala Pati-II, A.D.J. (FTC), Muzaffarnagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar for His Lordship's kind perusal and orders?
