May kindly see the property statement received online from Smt. Reeta Kaushik, Principal Judge, Family Court, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2020-2022 (2020-21 & 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2020-2022 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2020-2022 (2020-21 & 2021-22)**, the Gross income is Rs.62,01,563/- (Rs.49,73,213/- from salary and Rs.12,28,350/- from Interest on FDR & Saving A/c) and total deductions/repayment/ savings/ investment against GIS, GPF, FDR, PPF, Loan repayments including amount paid other than loan and Income Tax are Rs.61,74,522/- and the balance of her savings bank account is also decreased by Rs.8,35,485/- in this financial year from previous year's balance. Thus, a sum of Rs.8,62,526/- from Salary and Savings A/c, was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2020-2022 (2020-21 & 2021-22)

It is pertinent to mention here that her husband is posted as Presiding Officer M.A.C.T. in the Scale 67,210/-1,540/-70,290/- in the above period (as mentioned by the officer).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2018-2020 (2018-19 & 2019-20) online against Case Id: P00001032021 (Old Case Id : 2075) and the same has been seen by Hon'ble Mr. Justice Salil Kumar Rai, the then Administrative Judge, Faizabad Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2020-2022 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has firstly submitted movable and immovable property statements of the financial year 2020-2022 (2020-21 & 2021-22) vide online dated 07.04.2023. As such, there is 7 (seven) days delay in submitting the same from the part of the officer for which she has stated in her online reply dated 12.08.2024, that:

*"My humble submission is that Statements of Immovable and Movable properties held by me for the year 2020-21 and 2021-22 were due for submission before 31-03-2023, and I submitted the same on 30-03-2023.*

*I was transferred from Ayodhya to Distt. Jaunpur on 24.05.2022 and some papers mismanaged during the course of transportation of house hold articles from Ayodhya to Jaunpur. As soon as I could trace out the relevent papers, I prepared my statements which could be submitted on 30.03.2023. if there is any delay in submission of the proprty statements, it is not willful, it is due to circumstances and I apologize for the same. Kindly consider and approve my statements for the year 2020-21 and 2021-22and make the same part of records."*

May, therefore, if approved, property statements for the financial year 2020-2022 (2020-21 & 2021-22) of Smt. Reeta Kaushik, Principal Judge, Family Court, Jaunpur, be laid before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders?
