In the financial year 2021-2023 (2021-22 & 2022-23), the Gross income from salary is Rs.42,10,267/- and total deductions/savings/investment against NPS, GIS, Insurances, loan repayments, SIPs, PPF, Sukanya Samriddhi Account and Income Tax is Rs.21,52,791/- and the balance of his savings bank account(s) is also increased by Rs.52,452/- in this financial year from previous year's balance, total of which is Rs.22,05,243/-. Thus, a sum of Rs.20,05,024/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2021-2023 (2021-22 & 2022-23).

It is pertinent to mention here that his mother Smt. Tara Rai have annual income of Rs.2 lacs approx. by profession as farmer and his wife Smt. Swati Rai have annual income of Rs.9,60,011.37/- & Rs.10,68,708.66/- in the financial year 2021-22 & 2022-23 respectively by profession as Assistant Manager, Union Bank of India.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-2021 (2019-20 & 2020-21) online against Case Id: P00022962021 (Old Case Id: 4427) and the same has been seen by Hon'ble Mr. Justice Piyush Agrawal, the then Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-2023 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-2023 (2021-22 & 2022-23) vide online dated 02.04.2023. As such, there is no delay in submitting the same.
