May kindly see the property statement received online from Smt.Chetna Tyagi, Additional Civil Judge (Senior Div.), Sant Kabir Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary & arrears is Rs.20,80,996/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, LIC, PLI and the balance of her bank account(s) is also enhanced by Rs.1,59,690/- in this financial year from previous year's balance, total of which is Rs.7,76,902/-. Thus, a sum of Rs.13,04,094/- was therefore available with her to meet out the household expenditure of her family consisting two members in both of the financial years.

It is pertinent to mention here that officer's husband is also working as Judicial Magistrate, having monthly income of Rs.93,115/- (approx.), as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted her property statement upto the the financial year 2018-20 (officer was then posted in Ramabai Nagar) and the same has also been submitted online against Case Id : P00003882021 before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. She has submitted her movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) online vide application dated 31.03.23. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Smt. Chetna Tyagi, Additional Civil Judge (Senior Div.), Sant Kabir Nagar be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
