May kindly see the property statement received online from Sri Sanjay Raj Pande, Civil Judge (Senior Div), Sant Kabir Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income from salary & arrears is Rs.20,95,024/- and total deductions/savings/investment against NPS, GIS, Income Tax, PPF, PLI & loan is Rs.8,55,339/-. Thus, a sum of Rs.12,39,685/- was therefore available with him to meet out the household expenditure of his family consisting two members in both of the financial years. And the balance of his savings bank account is also reduced by Rs.2,111/- in this financial year from previous year's balance.

It is pertinent to mention here that officer's wife is also working as Civil Judge (Junior Div.), having monthly income of Rs.88,215 (approx.), as mentioned by the officer.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2018-20 and the same has been approved online against Case Id : P00004282021 by Hon'ble Mr. Justice Subhash Vidyarthi, the then Administrative Judge, Ramabai Nagar Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e., 2022-23 upto March 2023. He has submitted his movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) online vide application dated 31.03.23. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Sanjay Raj Pande, Civil Judge (Senior Div), Sant Kabir Nagar be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir Nagar Judgeship for His Lordship's kind perusal and orders?
