May kindly see the property statement online received from Sri Sharjil Khan, Addl. Civil Judge (Sr. Div.)/ACJM, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2020-22 (2020-21 & 2021-22) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2020-22 (2020-21 & 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2020-22 (2020-21 & 2021-22), Gross income (from salary & other sources) is Rs. 25,54,051/- and total deductions/savings/ investment against NPS, GIS, Income Tax, LIC and the balance of his savings bank account(s) is also enhanced by Rs.3,98,650/- in this financial year from previous year's balance, total of which is Rs.10,69,561/-. Thus, a sum of Rs.14,84,490/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

It is pertinent to mention here that the officer's wife is advocate and earning 4.5 lac per annum.

In this connection, it is submitted that the Officer has already submitted his property statement upto the financial year 2018-20 (2018-19 & 2019-20) and the same has also been processed online against Case Id : P00016992021 (Old Case Id : 3817) before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-22 (2020-21 & 2021-22) in its next financial year i.e. 2022-23 upto March 2023. He has submitted movable and immovable property statements for the financial years 2020-22 (2020-21 & 2021-22) vide online dated 12.09.2023. As such, there is delay in submitting the same from the part of the officer. The officer has stated in the remark column that "With heavy heart it is informed that my parents Mr Adil Khan and Naheed Fatima left for heavenly abode on 24-04-2021 at Panacea Hospital, Gorakhpur during Corona Pandemic. That Fazeel Ahmad Khan (Brother) and myself are surviving legal heirs of Late Mr Adeel Ahmad Khan and Late Mrs Naheed Fatima. That Succession for all movable and immovable property (including savings in bank account) has been applied jointly by me and my brother."

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 & 2021-22) of Sri Sharjil Khan, Addl. Civil Judge (Sr. Div.)/ACJM, Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
