May kindly see the property statement received online from Smt. Sumbul Irshad, Civil Judge (Junior Div.), Bansgaon-Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2021-23 (2021-22 & 2022-23) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**(1) In the financial year 2021-23 (2021-22 & 2022-23)**, the Gross income from salary is Rs. 23,31,033/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax and Insurances are Rs.6,08,350/- and the balance of her savings bank account is also enhanced by Rs.6,17,469/- in this financial year from previous year's balance, total of which is Rs.12,25,819/-. Thus, a sum of Rs. 11,05,214/- was therefore available with her to meet out the household expenditure of her family consisting two members of the financial year 2021-23 (2021-22 & 2022-23).

It is also pertinent to mention here that the Officer's husband Mohd Suhail is a Judicial Officer whose total income from salary is Rs.23,33,393/- in the financial year 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21), online against Case Id : P00059472022 and the same has been seen by Hon'ble Mr. Justice Sanjay Kumar Pachori, the then Administrative Judge, Pilibhit Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. She has submitted her movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 07.4.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2021-23 (2021-22 & 2022-23) of Smt. Sumbul Irshad, Civil Judge (Junior Div.), Bansgaon-Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
