In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2021-23 (2021-22 & 2022-23) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial year 2021-23 (2021-22 & 2022-23), the Gross income from salary is Rs.23,33,393/- and total deductions/savings/investment against NPS, GIS, Income Tax is Rs.4,59,941/- and the balance of his savings bank account(s) is also enhanced by Rs.14,834/- in this financial year from previous year's balance, total of which is Rs.4,74,775/-. Thus, a sum of Rs.18,58,618/- was therefore available with him to meet out the household expenditure of his family consisting two members of the financial year 2021-23 (2021-22 & 2022-23).

It is also pertinent to mention here that the officer's wife Mrs. Sumbul Irshad is a Judicial Officer whose total income from salary is Rs.23,31,033/- in the financial year 2021-23 (2021-22 & 2022-23).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2019-21 (2019-20 & 2020-21) online against Case Id : P00059492022 and the same has been processed before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2021-23 (2021-22 & 2022-23) in its next financial year i.e., 2023-24 upto March 2024. He has submitted movable and immovable property statements of the financial year 2021-23 (2021-22 & 2022-23) vide online dated 07.04.2023. As such, there is no delay in submitting the same.
